When are Classes?

Classes are generally **one** afternoon-evening per week and **weekends** both Saturdays and Sundays AM-PM. Two classes are scheduled on the weekday, three on the weekend days. Students may register for classes upon enrollment. Students must register for a minimum of 12 credits per trimester in order to maintain full-time status and be eligible for financial aid.

Do You Offer Online Classes?

The Eastern School of Acupuncture does not offer online classes.

Does the Eastern School of Acupuncture offer an accelerated program for, chiropractors, physicians and other students in the medical field?

There is no accelerated program for acupuncture. A possibility of transfer from some of the western medical classes required by the Eastern School may occur for students depending on their academic background, however this is strictly on an individual basis and requires a current license in the individual field.

Massage school A&P credits are accepted from an accredited school and only with a current license.

What if I do not have 4 credits in Human Biology?

Applicants may take the CLEP Biology exam in lieu of taking a 4 credit Human Biology course. A grade of 56 or greater mandatory to meet the educational requirement for entrance into the program.

What is the Application Deadline for the September 2016 semester?

All official paperwork for a completed application is due July 15, 2016.

How long is the Program?

Acupuncture is a 3 year program. All students must complete the entire acupuncture program within 4 ½ years.

Does my degree/90 credits have to be in any particular field for eligibility into the program?

There is no particular field or degree requirement for credits. The Eastern School of Acupuncture has a diverse group of students from many academic backgrounds.

Does the Eastern School of Acupuncture provide student housing?

Do I have to receive any vaccinations to attend the student clinic?

All applicants under the age of 30 must submit their vaccination records when applying.

The Eastern School of Acupuncture requests that students receive a Hepatitis B vaccine; however you may sign a vaccination declination form if you do not wish to receive a vaccination.

Information for Transfer Students

The Eastern School does accept transfer credits from accredited acupuncture schools located in the United States. Credits are accepted on a case by case basis and are based on comparison to the Eastern School curriculum. Official transcripts are required to apply for the acupuncture program.

Information for Foreign Students

Does the Eastern School of Acupuncture provide student visas?

The state of NJ considers acupuncture a vocational program and non-degree bearing, therefore we cannot provide student visas according to the Federal Government.

TOEFL

Foreign students who have not graduated from a school in the US must satisfy a score of a score of 80 or greater on the iBT internet exam.

What if My Degree is from a Country Other than the US?

Financial Aid for Foreign students

You must be a US citizen or eligible noncitizen.

- You must have an Arrival Departure Record (I-94) from US Citizenship and Immigration Services (USCIS) showing one of the following designations:
- 1. Refugee
- 2. Asylum Granted
- 3. Cuban-Haitian Entrant, Status Pending
- 4. Conditional Entrant (valid only if issued before 4/1/80)
- 5. Parolee (you must be paroled into the US for at least one year, and you must be able to prove evidence from the USCIS that you are in the US for other than a temporary purpose and intend to become a citizen or permanent resident)

Ш	If you have only a Notice of Approval to Apply for Permanent Residence (I-1/1 or I-464), you are NOT eligible for federal student aid.
	If you're in the US on certain visas, including an F1 or F2 student visa, or a J1 or J2 exchange visitor visa, you're NOT eligible for federal student aid.
